Some or all of these definitions may be found in this report:

Maximum Contaminant Level (MCL) - the highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.

Maximum Contaminant Level Goal (MCLG) - the level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.

Maximum Residual Disinfectant Level (MRDL) - the highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.

Maximum Residual Disinfectant Level Goal (MRDLG) - the level of a drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants.

Below Detection Levels (BDL) - laboratory analysis indicates that the contaminant is not present.

Not Applicable (N/A) - does not apply.

Parts per million (ppm) - or milligrams per liter, (mg/l). One part per million corresponds to one minute in two years or a single penny in \$10,000.

Parts per billion (ppb) - or micrograms per liter, (μ g/L). One part per billion corresponds to one minute in 2,000 years, or a single penny in \$10.000.000.

Parts per trillion (ppt) - one part per trillion corresponds to one minute in 2,000,000 years, or a single penny in \$10,000,000,000.

Parts per quadrillion (ppq) - one part per quadrillion corresponds to one minute in 2,000,000,000 years or one penny in \$10,000,000,000,000.

Picocuries per liter (pCi/L) - a measure of the radioactivity in water. **Millirems per year (mrem/yr)** - measure of radiation absorbed by the body.

Million Fibers per Liter (MFL) - a measure of the presence of asbestos fibers that are longer than 10 micrometers.

Nephelometric Turbidity Unit (NTU) - a measure of the clarity of water. Turbidity has no health effects. However, turbidity can provide a medium for microbial growth. Turbidity is monitored because it is a good indicator of the effectiveness of the filtration

Variances & Exemptions (V&E) - State or EPA permission not to meet an MCL or a treatment technique under certain conditions. Action Level (AL) - the concentration of a contaminant which, if exceeded, triggers treatment or other requirements that a water system shall follow.

Treatment Technique (TT) - a required process intended to reduce the level of a contaminant in drinking water.

This report is designed to inform the public about the quality of water and services provided on a daily basis. Our commitment is to provide a safe, clean, and reliable supply of drinking water. We want to assure that we will continue to monitor, improve, and protect the water system and deliver a high quality product.

Rowan Water Inc. purchases water from the Morehead Utility Plant Board, which treats surface water from the Licking River. Activities and land uses upstream of the source can pose potential risks to your drinking water. These activities, and how they are conducted, are of interest to the entire community because they potentially affect your health and the cost of treating your water. Activities immediately upstream of your water supply intake are of special concern because they provide little response time to the water system operators. An analysis of the susceptibility of the Morehead Utility Plant Board's raw water supply to contamination indicates that the susceptibility potential is generally moderate. There are a few areas of high concern near the raw water withdrawal site. Farming sites located in the area present the possibility for the impact from the application of pesticides and fertilizer. Bridges and major road ways used to access the Cave Run Lake recreational area also pose a threat to the intake should an accidental release of a harmful substance be introduced into the water source. Another source of potential concern in the critical protection area is a small wastewater package treatment plant located in the area. Other sites of medium concern include a marina, a fish hatchery, the presence of an underground storage tank and a small grocery/gas station, and a manufacturing industry. The complete Source Water Assessment is available at the Water Treatment Plant for inspection.

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. More information about contaminants and potential health effects may be obtained by calling the Environmental Protection Agency's Safe Drinking Water Hotline (800-426-4791).

The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and, in some cases, radioactive material, and may pick up substances resulting from the presence of animals or from human activity. Contaminants that may be present in source water include: Microbial contaminants, such as viruses and bacteria, (sewage plants, septic systems, livestock operations, or wildlife). Inorganic contaminants, such as salts and metals, (naturally occurring or from stormwater runoff, wastewater discharges, oil and gas production, mining, or farming). Pesticides and herbicides,

(stormwater runoff, agriculture or residential uses). Organic chemical contaminants, including synthetic and volatile organic chemicals, (by-products of industrial processes and petroleum production, or from gas stations, stormwater runoff, or septic systems). Radioactive contaminants, (naturally occurring or from oil and gas production or mining activities). In order to ensure that tap water is safe to drink, EPA prescribes regulations that limit the amount of certain contaminants in water provided by public water systems. FDA regulations establish limits for contaminants in bottled water to provide the same protection for public health.

Some people may be more vulnerable to contaminants in drinking water than the general population. Immunocompromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice about drinking water from their health care providers. EPA/CDC guidelines on appropriate means to lessen the risk of infection by Cryptosporidium and other microbial contaminants are available from the Safe Drinking Water Hotline (800-426-4791).

Information About Lead:

Lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. Your local water system is responsible for providing high quality drinking water and removing lead pipes, but cannot control the variety of materials used in plumbing components in your home. You share the responsibility for protecting yourself and your family from the lead in your home plumbing. You can take responsibility by identifying and removing lead materials within your home plumbing and taking steps to reduce your family's risk. To understand the possible health effects described for many regulated contaminants, a person would have to drink 2 liters of water every day at the MCL level for a lifetime to have a one-in-a-million chance of having the described health effect.

A message from Morehead Utility Plant Board:

In October 2023, MUPB was in violation of state regulations regarding manganese levels in our finished water. Manganese levels exceeded the state's Secondary Maximum Contaminant Level (0.05mg/L) and we failed to report this to the Division of Water within 48 hours. The highest recorded level of manganese between 10/18/2023-10/22/2023 was 0.212mg/L. As a result, brown water was distributed in our system at that time. We have since taken remedial measures to ensure that we can respond more quickly to an event like this in the future and we are in compliance with all required remedial measures that the Division of Water has asked us to make.

Testing results showed that our system exceeded the standard, or maximum contaminant level (MCL), for trihalomethaness. The standard for trihalomethanes is 0.080 mg/L. It is determined by averaging all samples at each sampling location for the last 12 months.

Trihalomethanes averaged at one of our system's locations for: 4/1/2023 through 6/30/2023 was 0.081 mg/L

Some people who drink water containing trihalomethanes in excess of the MCL over many years may experience problems with their liver, kidneys, or central nervous systems, and may have an increased risk of getting cancer.

We are working with our supplier to minimize the formation of trihalomethanes while ensuring we maintain an adequate level of disinfectant. We have taken additional steps to increase flushing of water lines to determine if our efforts have been effective. We are also monitoring water storage tank levels and water flow patterns within the distribution system. We returned to compliance the following quarter. A Public Notice was issued at the time of non-compliance in 2023.
